## ASSIGNMENT OF LEASES

THIS ASSIGNMENT OF LEASES is made and entered into at San Diego, California as of this 10th day of May, 1977, by and between INTERHOPE, INC., a California corporation (hereinafter called "Assignor"), and AT THE COVE MANAGEMENT CORPORATION, a California corporation not for profit (hereinafter called "Assignee"), with respect to the following

## RECITALS:

A. A Lease was executed as of July 1, 1972 between Robert R. Jones and Lucille M. Jones, as Trustees, and E. R. Bourne, all as lessor, and Assignor, as lessee, a Memorandum of which was recorded July 14, 1972 as File/Page No. 181671 with the Office of the County Recorder of San Diego County, California, which Lease covers that certain real property located in the City of San Diego, County of San Diego, California more particularly described on Exhibit "A" attached hereto and made a part hereof (hereinafter called the "Jones Lease").

- B. A Lease was executed as of May 16, 1972 between
  Carmelite Waldo Webb, as lessor, and Assignor, as lessee, a
  Memorandum of which was recorded May 24, 1972 as File/Page
  No. 131039 with the Office of the County Recorder of San Diego
  County, California, which Lease covers that certain real property
  located in the City of San Diego, County of San Diego, California,
  more particularly described on Exhibit "B" attached hereto and
  made a part hereof (hereinafter called the "Webb Lease").
- Article XVIII of the Webb Lease, Assignor has created a leasehold condominium project comprised of both the Jones Lease and the Webb Lease and has conveyed condominium leases to all of the property covered by the Jones Lease and the Webb Lease. The purchasers of the condominium leases have assumed all of the obligations of the Assignor under both the Jones Lease and the Webb Lease, and pursuant to both Leases, Assignor has thereby been relieved and released from further liability or obligation under the Jones Lease and the Webb Lease.
- D. As part of the creation of the leasehold condominium project, Assignor caused to be prepared a Declaration of Restrictions covering the leaseholds created by the Jones Lease and the Webb Lease, which Declaration was recorded with the Office of the County Recorder of San Diego County, California on November 14, 1972 as File/Page No. 305235. The Declaration provides that upon conveyance of all of the leasehold condominiums in the condominium project, Assignor will execute, acknowledge and deliver to Assignee a

recordable written assignment in favor of Assignee of the leasehold estates created by the Jones Lease and the Webb Lease.

NOW, THEREFORE, Assignor hereby assigns and transfers to Assignee all of Assignor's right, title and interest in and to the Jones Lease and in and to the Webb Lease hereinabove described, and Assignee hereby agrees to and does accept the assignment and expressly assumes and agrees to keep, perform and fulfill all the the terms, covenants, conditions and obligations required to be kept, performed and fulfilled by Assignor as lessee thereunder, including the making of all payments due or payable on behalf of the lessor under each of said leases when due and payable.
